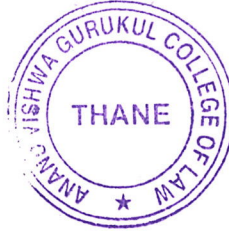

1. In house and Minority Students be admitted first as per the practice followed in the proceeding years for admission of F.Y.B.A./ B.Sc./B. Com. Classes only.
2. Fees:- Strictly to be charged as prescribed by the University . In addition, fees from Reserved Category students be charged as per circular No वि.क./भासशि(२४)/३६०/२००४ दिनांक २५ ऑगस्ट, २००४ and Circular No. वि.क./भासशि/पदवि/२/२०१३ दिनांक ७ जून, २०१३
3. No Colleges shall conduct their own CET test for admission for any course of University unless it is an Autonomous College.

Further, they are requested to form the Admission Cell/ Committee comprising of Senior Teaching Staff inclusive of representative from Reserved Category for smooth conduct of the admission process. **The vacant seats should be displayed on website** and be converted as per the prescribed procedure.
