The year-wise details of the course which highlight gender values are mentioned as under:

LLB Course

English I (First year BLS LL. B): The subject features various texts from Lord Denning's Due Process of Law and literature anthology Law and Literature by Dr. Shakuntala Bharwani which touch upon various aspects of gender equity.

History (First year BLS LL. B): The subject traces the history of the India which includes the Hindu Code Bill and Emancipation of Women.

Legal Writing and Legal Language (First year BLS LL. B): The subject introduces the students to Uniform Civil Code which has great influence on personal rights, with special reference to women's rights and policy for reservation of seats for women in the House of People.

Sociology (Second year BLS LLB): The subject cover all the important aspects of a society which including gender justice, women's rights and their emancipation

Constitutional Law (Third Year BLS LLB/ First Year LLB): The subject deals with various aspects of constitution pertaining fundamental rights and judicial activism for women.

Family Law- I (Third Year BLS LLB/ First Year LLB): The subject deals with personal laws of Muslims, Christians, Parsis and the laws relating to succession and reflects the various rights provided for women such as dower, alimony, maintenance, etc.
